### Your privacy is very important to us. At Tennyson Bridlington we have a

few fundamental principles that we follow: We don't ask you for personal information unless we truly need it. (We

dislike services that ask you for things like your gender or income level for no apparent reason.) We don't share your personal information with anyone except to comply

with the law, develop our products, or protect our rights. We don't store personal information on our servers unless required for

the on-going operation of our site. It is Tennyson Bridlington's policy to respect your privacy regarding any information we may collect while operating our website.

Protection of Certain Personally-Identifying Information

Tennyson Bridlington discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Tennyson Bridlington's behalf or to provide services available at Tennyson Bridlington's website, and (ii) that have agreed not to disclose it to others. Some of those employees,

If you are a registered user of an Tennyson Bridlington website and have supplied your email address, Tennyson Bridlington may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Tennyson Bridlington and our products. We primarily use our various product blogs to communicate this type of information, so we expect to keep this type of email to a minimum. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Tennyson Bridlington takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personallyidentifying and personally-identifying information. A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Tennyson Bridlington uses cookies to help Tennyson Bridlington identify and track visitors, their usage of Tennyson Bridlington website, and their website access preferences. Tennyson Bridlington's visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Tennyson Bridlington's websites, with the drawback that certain
